The meeting received comments from a parishioner about his continuing concerns over the planning application 24/01094/FUL Cranyke Farm Eastwell Road Scalford, an apparent lack of action from Melton Borough Council Planning to his concerns and what he held to be an inconsistency in the Parish Council's comments as a Statutory Consultee to similar applications in the past.

The Chair recorded the Parish Council's continued interest in the application and on receipt of details from the parishioner, then the Clerk will write to Melton BC Enforcement confirming the Parish Council's continuing interest.

Amanda Conn (Eaton Village Hall Secretary) outlined the steps taken so far to produce the 100th Village Show in Eaton, which would include Eastwell and Goadby Marwood, with plans to make this year a special occasion by bringing together the Hall, the Park and the Church to celebrate this with The Eaton Big Weekend.

There will be an open meeting in the village hall on <u>Thursday 23rd January at 7.00</u> for all villagers to come together to hear our Outline Plans and provide input. Parish Councillors will attend.

/3 The meeting received information caused by damage by the school bus being asked to pull over by the driver of a vehicle wanting to come down Main Street Eaton.

The footpath sign is damaged and needs repair and the mirror which is owned by numbers 23 and 25 Main Street is cracked and may need replacing. In addition the railings are now quite bent and may also need replacing.

The Clerk advised that the Parish Council should not be liable for any damage to the mirror and that other reported items were the responsibility of Melton BC.


